Sorg, Gill

1. My top priorities include infrastructure improvement and economic development. We need improved infrastructure – such as high-speed internet – to grow and attract business, and more, higher-paying jobs will bring new wealth to the city and reduce poverty. This new wealth, in turn, should be used to improve infrastructure even further, such as building parks in District 5. Over the past eight years, parks have already doubled in number.



2. In addition to infrastructure improvements, I favor incentives aimed at attracting new and more diverse businesses, including but not limited to value added agriculture, aerospace, manufacturing, logistics, film and other media. Promoting tourism, as our public land National Monuments OMDP can do, also brings outside money to the city.

3. District 5 needs more parks and recreational activities. 4. Flores, Yvonne

1. Priorities for the City: Implementing a plan that employs language and factors that focus on connectivity for all residents to meet the needs of a growing population; and keeping our residents safe. Public safety is of utmost importance. Consequently, funding our police and fire departments is essential to have the personnel and equipment to keep our residents safe.



2. Economic development must utilize natural resources, wind and solar energy which are sustainable. Businesses must be allowed to have licensing and inspections coordinated to allow expeditious approval and allow business to prosper. The City has a wealth of resources for businesses to explore. The airport management advisory board should stimulate economic growth with the current land available for expansion, creating businesses necessary to serve travelers, and encouraging more travel and industry.

3. The City has proposed facilities of many kinds in the Plan4LasCruces. Additionally, more parks such as Desert Trails, for example, which preserve public lands, would flourish. Currently, the City is in its next phase of expanding the Regional Aquatic Center. I would like to see effective transportation services such as vans, shuttles, etc., at little or no cost to the City which would allow residents to enjoy the City in its entirety resulting in connectivity.

4. According to the U.S. Census Bureau's population estimates, July 1, 2016, Las Cruces' population was 101,759; median household income (2015), \$41,330; per capita income (2015), \$22,132; persons in poverty, 24.4%; owner occupied homes were 55.4% from 201-2015 with median cost of ownership being over \$148,600. The greater need is affordable housing. Improved employment and education will alleviate the barriers for home ownership.

1. Economic development. I currently serve on both the Mayor's Economic Development committee and the Economic Development Policy Review Committee and have been asked by the members to chair the Policy Review committee. Job creation. With an unemployment rate higher than Albuquerque and Santa Fe it is critical that we continue the process outlined in our new 5 year Strategic Plan. I want to see new business relocate here and our local businesses expand.



2. The city Council adopted a new 5 year Strategic Plan in May. The Strategic Plan consists of 20 priorities organized under four themes: Capital Improvements & Infrastructure, Communication, Involvement and Follow-up, Economic & Community Development, Education. 3. As part of the strategic plan, the community will have council-approved, results-oriented plans for the expansion and improvement of parks, public facilities, sidewalks and median landscaping. Specifically, improvements to senior centers, library, museums and playgrounds will be addressed.

4. There has been a long standing need for affordable housing. It is my hope that the city will officially recognize the problem and help Rose Garcia (a nationally recognized expert) with Tierra del Sol and other local organizations obtain the necessary funding from HUD, USDA, MFA, etc.. Final decisions should be made by council only after meetings with the various stakeholders and community at large.

She has also served as a Domestic Violence hearing officer and knows how to conduct fair and orderly hearings while maintaining a calm, professional environment. She also has extensive experience working with self-represented litigants.



2. Las Cruces needs a Homeless Court Program to manage frequent, minor non-violent offenses by individuals who suffer from substance use or mental health disorders. Incarceration is expensive and accomplishes nothing to address the root problems. The Court should consider offering occasional evening or weekend sessions to accommodate residents for whom the loss of a day's income is often a greater hardship than the fine they may end up owing.

1. I have over 25 years of legal experience. I was a prosecutor for over 10 and handled numerous domestic violence and dwi cases which are some of the cases in municipal court. I have experience as judge in both District and Magistrate Court. As a magistrate judge for over a year I presided over traffic and misdemeanor cases similar to the cases that are in municipal court. 2. One of the biggest complaints I hear about municipal court is the wait time. I will work with the presiding judge to reduce that time and to make the court more accessible to our working citizens to reduce the time they must take off work to attend court. I will also seek to work with the mayor and city council to address funding issues for the court to improve access by the public.

1. I am the current Municipal Judge with over 4 years of experience. During my tenure I have heard over 80,000 cases involving traffic, criminal, animal control and codes matters. My career as a judge, Domestic Violence Special Commissioner, Special Assistant Attorney General, prosecutor, defense attorney and a member of the Community Corrections Board has allowed me to cover every aspect of the inner workings of the Municipal Court and the justice system.



2. Both Judge Ryan and myself are working with the City Council to obtain a new courthouse. The current building is over 100 years old and a new facility would go a long way in better serving the people of Las Cruces. Further upgrading the existing computer system would allow expediting cases and allowing our citizens to avoid time spent in court while waiting to see a judge.
